SUBJECT: PART IV ON TRADE AND DEVELOPMENT - STATUS OF THE PROTOCOL AND OF THE DE FACTO IMPLEMENTATION OF PART IV

THE PROTOCOL HAS BEEN ACCEPTED BY THE FOLLOWING THIRTY CONTRACTING PARTIES 1:

THE FOLLOWING SIXTEEN CONTRACTING PARTIES HAVE SIGNED THE PROTOCOL "SUBJECT TO RATIFICATION" OR "AD REFERENDUM":

AUSTRIA GREECE NIGER ITALY NORWAY BELGIUM BRAZIL LUXEMBURG PERU CHILE MADAGASCAR TOGO FINLAND UPPER VOLTA KINGDOM OF THE FEDERAL REPUBLIC OF GERMAN **NETHERLANDS**

THE PROTOCOL, WHICH IS OPEN FOR ACCEPTANCE UNTIL 31 DECEMBER 1965, WILL ENTER INTO FORCE WHEN IT HAS BEEN ACCEPTED BY TWO THIRDS (FORTY-FOUR) OF THE CONTRACTING PARTIES HOWEVER, A NUMBER OF CONTRACTING PARTIES HAVE INDICATED TO THE SECRETARIAT THAT, BECAUSE OF DELAYS IN THEIR LEGISLATIVE PROCESSES, IT WILL NOT BE POSSIBLE FOR THEM TO ACCEPT THE PROTOCOL UNTIL THE LATE SPRING OF 1966. THEREFORE, IT NOW SEEMS UNLIKELY THAT THE PROPOSED AMENDMENT TO THE AGREEMENT WILL BE ACHIEVED BY THE END OF THE YEAR. FURTHERMORE, THE DECLARATION

PROVIDING FOR THE <u>DE FACTO</u> IMPLEMENTATION OF PART IV EXPIRES ON 31 DECEMBER. CONSEQUENTLY IT APPEARS THAT, UNLESS ACTION IS TAKEN BY THE CONTRACTING PARTIES, THE PROVISIONS OF PART IV WILL HAVE NO STATUS AS FROM 1 JANUARY 1966, AND THERE WILL BE NO LEGAL BASIS FOR THE COMMITTEE ON TRADE AND DEVELOPMENT.
