THE COUNCIL MAY ALSO WISH TO REVIEW THE AGENDA FOR THE SESSION IN ORDER TO ALERT GOVERNMENTS AND THE SECRETARIAT ON PREPARATIONS TO BE MADE

12. PROGRAMME OF MEETINGS

PROPOSALS FOR MEETINGS TO BE HELD UP TO THE TWENTY-THIRD SESSION WILL BE PUT FORWARD

COUNCIL MEMBERS ARE REQUESTED TO ADVISE ME BY 10 DECEMBER OF THE COMPOSITION OF THEIR DELEGATIONS. CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS, NOT MEMBERS OF THE COUNCIL, AND INTERGOVERNMENTAL ORGANIZATIONS DESIRING TO BE REPRESENTED BY OBSERVERS SHOULD INFORM ME OF THE NAMES OF THEIR REPRESENTATIVES.
