SUBJECT: DECLARATION PROLONGING THE DE FACTO IMPLEMENTATION OF THE PROVISIONS OF THE PROTOCOL INTRODUCING PART IV

IN VIEW OF THE DELAY IN THE ENTRY INTO EFFECT OF THE AMENDMENTS PROVIDED FOR IN THE PROTOCOL AMENDING THE GATT TO INTRODUCE A PART IV ON TRADE AND DEVELOPMENT AND IN VIEW OF THE FACT THAT THE DECLARATION ADOPTED ON 8 FEBRUARY 1965 ON THE DE FACTO IMPLEMENTATION OF THE PROVISIONS OF THE PROTOCOL WILL EXPIRE ON 31 DECEMBER, THE COUNCIL OF REPRESENTATIVES AT ITS MEETING ON 15 DECEMBER DECIDED TO SUBMIT TO THE CONTRACTING PARTIES A NEW DECLARATION PROLONGING THE DE FACTO IMPLEMENTATION UNTIL THE TWENTY-FOURTH SESSION OF THE CONTRACTING PARTIES OR UNTIL THE AMENDMENTS ENTER INTO EFFECT. THE TEXT OF THE DECLARATION IS ... REPRODUCED HEREWITH.

CONSIDERING THAT THERE WILL BE SOME FURTHER DELAY IN THE ENTRY INTO EFFECT OF THE AMENDMENTS PROVIDED FOR IN THE PROTOCOL AMENDING THE GATT TO INTRODUCE A PART IV ON TRADE AND DEVELOPMENT,

RECOGNIZING THAT NO OBLIGATION WILL ARISE PRIOR TO THE ENTRY INTO EFFECT OF THE SAID AMENDMENTS, AND

DESIRING TO PROCEED AS RAPIDLY AS POSSIBLE TOWARDS THE ATTAINMENT OF THE OBJECTIVES SET FORTH IN THE PROTOCOL,

EACH OF THE GOVERNMENTS ASSENTING TO THIS DECLARATION,

DECLARES THAT, UNTIL THE CLOSE OF THE TWENTY-FOURTH SESSION OF THE CONTRACTING PARTIES OR UNTIL THE AMENDMENTS ENTER INTO EFFECT, WHICHEVER DATE IS THE EARLIER, IT INTENDS TO IMPLEMENT THE AMENDMENTS ON A DE FACTO BASIS TO THE EXTENT ALLOWED BY EXISTING CONSTITUTIONAL AND LEGAL POSSIBILITIES.
