A. A MEETING OF THE INTERSESSIONAL COMMITTEE WILL HE HELD AT THE PALAIS DES NATIONS, GENEVA, GEGINNING AT 11 A.M. ON THURSDAY 23 JUNE 1955.

THE AGENDA FOR THE MEETING IS AS FOLLOWS:

- 1. REQUESTS BY HELGIUM AND LUXEMBURG FOR WAIVERS ON MALIMENANCE OF QUANTITATIVE IMPORT RESTRICTIONS (L/357 AND 366). (DETAILS OF THESE REQUESTS WILL BE DISTRIBUTED ON 6 JUNE)
- 2. FRENCH SPECIAL TEMPORARY COMPENSATION TAX ON IMPORTS.

AS REQUIRED BY THE DECISION OF 17 JANUARY 1955 (G/91, PACE 9), TO REVIEW THE MEASURES TAKEN BY THE REACH COVERNMENT TO IMPLEMENT ITS UNDERTAKING TO REMOVE THE TAX AS SOON AS POSSIBLE.

 - (c) NEXT MEETING OF INTERSESSIONAL COMMITTEE.

MENDERS OF THE COMMITTEE ARE ASKED TO INFORM ME OF THE MANNES OF THE MANNES OF AND OTHER CONTRACTING PARTIES SHOULD NOTIFY THE MANNES OF ANY CHARGE THEY PROPOSE TO SEND TO THE MENTING.

B. A SPECIAL SESSION OF THE CONTRACTING PARTIES WILL BE HELD IN GENEVA BEGINNING ON 7 JULY TO CONSIDER THE RECOMMENDATIONS OF THE INTERSESSIONAL COMMITTEE UNDER ITEM 1 OF THAT COMMITTEE'S AGENDA AND ANY OTHER RECOMMENDA-TIONS WHICH THE COMMITTEE MAY DECIDE REQUIRE THE ATTENTION OF THE CONTRACTING PARTIES BEFORE THE TENTH SESSION. THE HOUR AND PLACE OF THIS MEETING WILL BE INCLUDED IN A LATER NOTICE. CONTRACTING PARTIES ARE ASKED TO INFORM ME OF THE NAMES OF THEIR REPRESENTATIVES.
