SUBJECT: INTERNATIONAL DAIRY ARRANGEMENT - PROTOCOL REGARDING CERTAIN MILK FATS - REMINDER

IN TAKING THE DECISION OF 3 MAY 1994, WITH RESPECT TO THE SUSPENSION OF MINIMUM PRICES FOR BUTTER AND ANHYDROUS MILK FAT, PARTICIPANTS AGREED TO PROVIDE TO THE SECRETARIAT, EVERY TWO MONTHS, THE MOST RECENT INFORMATION AVAILABLE TO THEM ON THEIR EXPORT SALES (QUANTITIES, DESTINATION AND PRICES (US\$, F.O.B.)) OF BUTTER AND ANHYDROUS MILK FAT (PARAGRAPH 6 OF DPC/PTL/40). PARTICIPANTS ARE THUS REQUESTED TO PROVIDE SUCH INFORMATION REGARDING THEIR EXPORT ACTIVITIES FOR NOVEMBER AND DECEMBER 1994 TO THE SECRETARIAT AS SOON AS POSSIBLE. THE FORMAT FOR EXPORT SALES BY DESTINATION MAY BE USED FOR THIS PURPOSE. A COPY OF THE FORMAT, IN ENGLISH ONLY, IS ATTACHED. PARTICIPANTS ARE REQUESTED TO SEND SUCH INFORMATION, BY MAIL OR HAND DELIVERY, TO MRS. GRETCHEN STANTON OR MR. THOMAS FRIEDHEIM AT THE SECRETARIAT.

LORSQU'ILS ONT DECIDE, LE 3 MAI 1994, DE SUSPENDRE L'APPLICATION DES PRIX MINIMAUX POUR LE BEURRE ET LES MATIERES GRASSES LAITIERES ANHYDRES, LES PARTICIPANTS SONT CONVENUS DE COMMUNIQUER TOUS LES DEUX MOIS AU SECRETARIAT LES RENSEIGNEMENTS LES PLUS RECENTS DONT ILS DISPOSERONT SUR LEURS VENTES A L'EXPORTATION (QUANTITES, DESTINATIONS ET PRIX (DOLLARS EU, F.A.B.)) DE BEURRE ET DE MATIERES GRASSES LAITIERES ANHYDRES (DPC/PTL/40, PARAGRAPHE 6). LES PARTICIPANTS SONT DONC INVITES A COMMUNIQUER DES QUE POSSIBLE AU SECRETARIAT LES RENSEIGNEMENTS CONCERNANT LEURS ACTIVITES D'EXPORTATION POUR NOVEMBRE ET DECEMBRE 1994.
