1. To consider the budget estimates for 1951 and the financial documents submitted by the Executive Secretary and to make appropriate recommendations to the Contracting Parties.

2. To recommend a scale of contributions for consideration by the Contracting Parties.

Mandat:

1. Examiner les prévisions budgétaires pour 1951 ainsi que les documents relatifs aux finances, soumis par le Secrétaire exécutif et présenter aux Parties Contractantes des recommandations appropriées.

2. Recommander et soumettre pour examen aux Parties Contractantes un barème des contributions.

Working Party "C" on the Budget

The first Working Party on the Budget Estimates for 1951 convened on 8 November 1950. The following matters were discussed :

1. Outstanding contributions
2. Estimates of Expenditure 1951  
(GATT/CP.5/10 - Page 3 and Pages 6 - 11)

In the course of the meeting the following decisions were taken :

1. Outstanding Contributions

To enable the Working Party to assess financial needs of the Organisation for the first quarter of 1951, the Secretariat was instructed to write letters to those governments whose contributions for 1949 and 1950 were still outstanding and who had indicated no date for payment. These governments were to be asked to inform the Secretariat in writing when payment might be expected, or alternatively to arrange for a representative to attend the next meeting of the Working Party.

The question of contributions for 1951 was also considered. The governments of the United Kingdom, the United States, Canada, South Africa, Indonesia and Southern Rhodesia having stated when they hoped to remit contributions, the Secretariat was requested to write to the governments of the other countries concerned to ask when payment might be expected.

2. Estimates of Expenditure 1951.

The budget estimates were considered item by item.

Part I : Meetings

It was agreed that the provision for Other Meetings should be reduced from \$20,000 to \$10,000 on condition that the meetings to be convened during 1951 would not exceed :

- 1) Sixth Session of the Contracting Parties to be held in Geneva of not more than six weeks' duration,
- 2) A short special session to discuss, inter alia, the Schuman Plan,
- 3) One short, inter-sessional meeting of a working party.

The total estimate for Part I : Meetings, was accordingly reduced from \$72,000 to \$62,000.

Part II : Secretariat

Reduction of the estimate of \$158,431 for Salaries and Wages to \$148,431 by the exclusion of the provision of \$10,000 for Consultants was approved.

The budget estimates for the following were also approved :

The total of Part II : Secretariat, was therefore reduced by \$10,000 to \$305,281; the total appropriation resulting in a figure of \$367,281.

It was resolved to amend the explanatory text of the estimates to provide for the changes as approved, and in the case of Travel on Official Business, to insert the following statement :

"This estimate is calculated to cover the travel of regular staff members on mission."

SCALE OF CONTRIBUTIONS TO THE BUDGET FOR 1951

Revised Scale Using the "Unit" Method

It has been proposed that the total budget of the Contracting Parties should be reduced by the amount of U.S. \$20,000.- The following is a revision, consequent on that proposal, of the table on page 3 of GATT/CP.5/13.
