It should be noted that for cables to be sent to the United Nations and TAB the services of the United Nations Field Service radio network are to be used; specific forms are to be used for such cables. Detailed instructions for the preparation of airgrams, telegrams and radio messages are given in ICITO Office Circular No. 36.
