#### COMMENTS ON THE DOCUMENTATION

#### European Communities

In its Report (1986)(L/6073, paragraph 28), adopted by the CONTRACTING PARTIES at their forty-second Session in their Decision establishing the Technical Group (L/6100), the Group on Quantitative Restrictions and Other Non-Tariff Measures requested contracting parties to inform the secretariat by 31 January 1987 of any specific amendments they wished to make to the existing basic documentation and analyses.

In a communication dated 18 December 1986, the Permanent Delegation of the European Communities has submitted comments on the United Kingdom section of NTM/W/17/Add.2/Corr.1, on pages 46 and 47 of that document.

#### The comments fall under three headings:
