## ANTI-DUMPING AND COUNTERVAILING DUTIES

The Government of the United States have communicated to the secretariat the following changes to be made in the GATT publication "Anti-Dumping and Countervailing Duties" as amended by document MGT(59)122. These changes will be incorporated in a corrigendum to document MGT(59)122 together with any other changes which may be notified during the second meeting of the Group of Experts on Anti-Dumping and Countervailing Duties taking place from 18-22 January 1960.

"The following changes should be made in the publication 'Anti-Dumping and Countervailing Duties' (Sales No. GATT/1958-2), as amended by document MGT(59)122, to bring the information up to date as of 31 December 1959 and to correct certain statistics.

Page 14 - table: That portion of the table relating to the United States should read as follows:

In the last sentence of the answer, change '31 December 1958' to '31 December 1959' and change 'ten' to 'twelve'. Add the following new sentence:

'One case was still under consideration by the Tariff Commission as of 31 December 1959, ' Spec(60)3 Page 2

## "COUNTERVAILING DUTIES (pages 123-126)

Question 5(b): Change to read:

95 (this figure includes all investigations through 31 December 1959, whether initiated by complaint or by the Government and includes the requests which led to the issuance of the four countervailing duty orders listed in the first portion of the reply to (a) above.

# "APPENDIX I (pages 127-130)

Paragraph 13: Change to read:

When possible, the article sold to the United States is compared to identical or similar articles sold in the home market. If neither identical nor similar articles are sold in the home market, or if the quantity sold in the home market is so small as to form an inadequate basis for comparison, then comparison is made with identical or similar articles sold for exportation to countries other than the United States. In making comparison with a similar article, allowances are made for any differences in costs of manufacture or production.

#### Paragraph 15:

Change '1958' in the fourth sentence of paragraph 15 to '1959' and change 'ten' to 'twelve'. Add the following new sentence:

'One case was still under consideration by the Commission as of 31 December 1959.'

#### Paragraph 16:

Change '1958' to '1959' and change '251' to '289'.

"Revised regulations pertaining to anti-dumping are in the process of preparation but have not yet been issued in final form."
