GATT INSTRUMENTS DEPOSITED WITH THE SECRETARY-GENERAL
OF THE UNITED NATIONS

Texts Contained in the United Nations Treaty Series

The GATT secretariat is requested to provide from time to time copies of certain legal instruments which were drawn up by the CONTRACTING PARTIES and deposited with the Secretary-General of the United Nations prior to February 1955. Since that date the Executive Secretary acts as depositary for all GATT legal instruments. Acting as depositary for the former instruments the Secretary-General has published only a limited number to provide certified true copies to governments; no additional copies have been available. However, following the entry into force of these instruments, they are published in the United Nations Treaty Series. The GATT secretariat has obtained a limited number of copies of the relevant volumes of the Treaty Series with a view to making them available to acceding governments, etc., which have never received the texts of these instruments. The instruments in question are listed below along with the corresponding volume and page number therein. Any instruments not listed hereunder are contained in publications which can be obtained from the GATT secretariat.
