TRADE WITH HUNGARY

Communication from the Delegation of Hungary

The following communication has been received from the delegation of Hungary.

With reference to the notification¹ submitted by the Commission of the European Communities in conformity with paragraph 4(c) of the Protocol of Accession of Hungary to the GATT, upon instruction of my authorities I am sending the Hungarian remarks concerning the notification referred to above, with the request that they be circulated as a GATT document prior to the Session of the Working Party on Trade with Hungary on 19 November 1979.

Hungarian Remarks Concerning the Notification Submitted in Conformity with Paragraph 4(c) of the Hungarian Protocol of Accession by the Commission of the European Communities

1. ad. LIST "A"

- ad. I/1.: The regulation by which BTN's 56.06, ex 59.04 and ex 62.04 have been liberalized is unknown;
- ad. I/2.: The regulation by which BTN's 30.04, 97.02 and 97.06C have been liberalized is unknown;
- ad. I/3.: The suspension of quantitative restrictions, as a result of the conclusion of the Textile Agreement between the European Economic Community and Hungary, cannot be regarded as measures of liberalization, because the said restrictions have not been eliminated, only suspended. (Hungary regards that the liberalized situation is still prevailing for those products which had already been liberalized but for which Hungary has accepted auto-limitations.) Hungary reserves its position on this notification, submitted as measures taken in accordance with paragraph 4(a) of the Hungarian Protocol of Accession.

ad.II.: The regulation of the Community by which the United Kingdom liberalized BTN's 39.07.45, 40.13.11-18, 43.03.30, 54.03.10-69 and 54.04.10-90 is unknown.

On the basis of the foregoing, Hungary accepts the following measures as taken in accordance with paragraph 4(a) of the Hungarian Protocol of Accession:
