JOINT MEETING OF THE COMMITTEES ON A SURVEY OF GOVERNMENT MEASURES TO EXPAND DOMESTIC CONSUMPTION OF DAIRY PRODUCTS

Draft Report

1. The Committee of the Protocol Regarding Certain Milk Powders, the Committee of the Protocol Regarding Milk Fat and the Committee of the Protocol Regarding Certain Cheeses held a joint meeting on 16 December 1983. The meeting was devoted to further study of government measures to expand domestic consumption of dairy products, on the basis of information furnished by delegations interested in this work.
2. The Committees adopted the report on their joint meeting held on 28 September 1983. The document will be circulated as DPC/P/23, DPC/F/23, DPC/C/23.
3. The Committees had before them a note containing a compilation of information furnished, which the secretariat had been requested to prepare (document DPC/P/W/11/Suppl.2, DPC/F/W/10/Suppl.2, DPC/C/W/10/Suppl.2). Delegations were invited to communicate any amendments to this document, which will accordingly be revised as necessary.
4. The representative of New Zealand said that although the note contained a lot of useful information, it did not highlight or emphasize in the script some important salient features. He said that his delegation would transmit to the secretariat a communication containing suggestions on this subject.
