ACCESSION OF CHINESE TAIPEI

Newly Promulgated or Revised Laws and Regulations

The following communication, dated 8 July 1994, has been received from the Representation of Chinese Taipei.

Further to the laws and regulations we sent to you in March and June 1993 in the context of our Memorandum on Foreign Trade Régime (please refer to the lists contained in L/7097/Add.4 and Add.5), I have the pleasure to forward to you as enclosed twenty-nine copies each of the newly promulgated or revised laws and regulations for distribution to the members of the Working Party.¹ A list of these new or revised laws and regulations is attached as List 1 for the convenience of your reference.
