ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notifications Under Article 2, Paragraph 1

Note by the Chairman

At its first meeting on 23 April 1974, the Textiles Surveillance Body received notifications under Article 2, paragraph 1, of the Textiles Arrangement from Australia, Austria, Finland, Guatemala, Hungary, Hong Kong/Canada, Hong Kong/United States, Israel, Republic of Korea, Mexico, Pakistan, Spain, Sri Lanka, Sweden, Switzerland and the United States. Copies of these notifications were distributed all members and their alternates along with the secretariat's summary tabulations, hich were prepared in accordance with the minimum notification requirements decided by the Textiles Committee at its March meeting.

The secretariat, in compliance with the request of the Textiles Surveillance Body, has asked for the details found to be lacking in the notifications received from Austria, Finland, Hungary, Republic of Korea, Mexico, Pakistan, Spain, Sri Lanka and Sweden as per the attached list.

Additional notifications of existing restrictions received by the secretariat from El Salvador, Hong Kong/Sweden, Hong Kong/Norway, Guatemalal and Norway are also attached.

Austria
