Pursuant to the provisions of paragraph 4 of article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my government to inform the Textiles Surveillance Body of the amendment of the wool and man-made fiber textile agreement between the Government of the United States of America and the Government of the Socialist Republic of Romania.

This amendment, which converts a former merged designated consultation level (two products) to a speccific limit, was agreed upon by the two governments to facilitate orderly development of exports of these products from Romania while at the same time avoiding disruptive effects in the U.S. market.

UNITED STATES AND SOCIALIST REPUBLIC OF ROMANIA AMEND BILATERAL TEXTILE AGREEMENT

The United States and the Socialist Republic of Romania exchanged letters dated June 12 and June 22, 1984 to effect an amendment to their bilateral textile agreement relating to trade in wool and man-made fiber textiles and textile products. The texts of the letters follow:

Dear Mr. Rapanu:

I refer to my letter to you dated May 25, 1984 in which I promised to reply to further information on proposed shipping levels of certain categories of textile exports from Romania to the United States. I also refer to the Agreement between the United States of America and the Socialist Republic of Romania relating to Trade in Wool and Man-made Fiber Textiles and Textile Products, with Annexes, effected by exchange of notes dated September 3 and November 3, 1980, as amended (The Wool and Man-made Fiber Agreement).

On behalf of my Government, I propose that the Wool and Man-made Fiber Agreement be amended as follows:

Annex B:

Group III

4th Agreement Year

Category 433/434 (three asterisks)

270,00 SYE

(Three asterisks) includes inter-category flexibility (swing)

This Category will be deleted from Annex C.

If this proposal is acceptable to your Government, this letter and your letter of confirmation on behalf of your Government shall constitute an amendment to the Wool and Man-made Fiber Agreement.
