DRAFT REPORT

With reference to the TSB recommendations made on October 26, 1984 consultations were held between the Governments of Indonesia and the United States in Jakarta from January 17 - 19, 1985.

Agreements were reached on four of the eight categories which had been reviewed by the TSB in October. Those four are as follows:

Category 317 = 9 million syd (317 - sublimit-sateens = 2 million)

Category 339 = 240.000 dozen Category 639 = 360.000 dozen Category 640 = 300.000 dozen

On category 315, the Government of Indonesia made every effort to reach a mutually satisfactory agreement. The Government of Indonesia offered a level almost one-third below Indonesia's export at the time of the request for consultations by the USA.

On category 320 and 331, the Government of Indonesia offered levels which were even below the annual level of US imports one month before the dates of request for consultations by the United States.

Based on the TSB recommendations contained in paragraphs 7 and 8 of the October recommendations, Indonesia believes it has been execeptionally forthcoming in its offers of export restraint levels in these two categories.

In category 604, the Government of Indonesia was disappointed at the lack of United States co-operation to rescind the restraint as the TSB had recommended in paragraph 5 of the TSB recommendations made on October 26, 1984.

Instead of rescinding the restraint, the United States modified the coverage from 604 to 604 pt-acrylic spun yarn.

Nevertheless, Indonesia offered to restrain exports at a level below the annual level of US imports one month before the request for consultations by the United States.

Despite Indonesia's willingness to put forth offers on export restraint levels which were well below Indonesia exports at the time of request for consultations, agreement was not for consultations, and even well below US imports at the time of such requests, agreement was not reached by the parties on these four categories.

In addition to the above discussed eight categories request for consultations in four other categories were considered during this meeting between the two Governments.

Agreement was reached on two of the categories:

Category 334 = 24.000 dozen Category 369 = 750.000 lbs

In category 361 no agreement was reached due to a large discrepency between each country's calculation of the minimum restraint level under paragraph 12 of the bilateral agreement.

The Government of Indonesia intends to make every effort to resolve the outstanding problems on the six categories (four categories under TSB review and two new calls) in which agreement were not reached, together with renewal of the bilateral agreement.

The present bilateral agreement expires on June 30, 1985. Should these efforts fail to result in an agreement, the Government of Indonesia may decide to present its case before the TSB.

MEMORANDUM OF UNDERSTANDING BETWEEN THE REPRESENTATIVES OF THE GOVERNMENTS OF INDONESIA AND THE UNITED STATES OF AMERICA JAKARTA, 17 - 19 JANUARY 1985

Representatives of the Governments of Indonesia and the United States met in Jakarta from January 17 to 19 and agreed on the following. Specific limit shall be established and prorated where appropriate for the current agreement year (July 1, 1984 - June 30, 1985) based on the following annual limits.
