## ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4:4

Amendment of the Bilateral Agreement between the United States and Indonesia

Note by the Chairman

Attached is a notification received from the United States of an amendment of its bilateral agreement with Indonesia. The parties have agreed to specific limits with respect to Categories 317, 339, 369 part (shop towels), 639 and 640. These categories (except Category 369 part) had been subject to TSB review under Article 11:4 and the parties had reported on the results of consultations following the TSB recommendations at its first 1985 meeting.

The text of the original agreement and previous amendments are contained in COM.TEX/SB/834, 950 and 1023. The TSB review under Article 11:4 is contained in COM.TEX/SB/1005 and the subsequent reports by the parties are contained in COM.TEX/SB/1044.

Pursuant to the provisions of paragraph 4 of Article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my government to inform the Textiles Surveillance Body of the amendment of the bilateral textile agreement between the Government of the United States of America and the Government of the Republic of Indonesia.

This amendment provides for specific limits on six additional categories. The limits were sought by the United States to deal with real risk of market disruption on the one hand, while insuring orderly development of trade in textile products from Indonesia on the other hand.

Four of the Categories concerned (317, 339, 639, and 640) had earlier been subjected to restraints pursuant to article 12 of the U.S.-Indonesian bilateral. These former restraints have now been replaced by the newly negotiated limits notified herein.1/

Copies of the notes giving effect to this amendment are enclosed herein.

UNITED STATES AND REPUBLIC OF INDONESIA AMEND BILATERAL TEXTILE AGREEMENT

The United States and the Republic of Indonesia amended their bilateral textile agreement by exchange of notes in Washington dated February 25 and February 26, 1985, respectively. Texts of the notes follow.

### UNITED STATES NOTE

Washington February 25, 1985

I have the honor to refer to the Arrangement regarding International Trade in Textiles, with annexes, done at Geneva on December 20, 1973, and extended by Protocol adopted on December 22, 1981 at Geneva (hereinafter referred to as the Arrangement), to consultations between representatives of the Government of Indonesia and the Government of the United States of America in Jakarta on January 17-19, 1985 (hereinafter referred to

as the consultations), and to the existing bilateral textile agreement of 1982, as amended, between the Republic of Indonesia and the United States of America (hereinafter referred to as the Agreement).

As a result of the consultations and in conformity with the Arrangement, I have the honor to propose amending the Agreement as follows:
