With reference to your letter dated 24.03.87, concerning the request for information on the status of quantitative restrictions imposed on the imports of textiles in Brazil according to Articles 11:11, 11:12 and 11:2 of the Arrangement, I have the honour to inform you that Brazil does not apply such restrictions with respect to textiles.

2. For the imports of textiles in Brazil, only normal procedures apply, that is, tariff duties and financial transactions tax (IOF), applicable on foreign-exchange Imports of textiles are further subject to administrative measures, such as the Import Program and the suspension of import licences, which have been duly notified to the Balance of Payments Committee of the GATT (document L/6126).
