Dear Ambassador Raffaelli,

With reference to your letter of March 24, 1987, and in pursuance of Article 11 of the Arrangement Regarding International Trade in Textiles, in particular paragraph 11 and 12 and 2 requesting information on the status of restrictions maintained on textile products covered by the Arrangement, I enclose herewith the required information as received for the Department of Trade of the Republic of Indonesia, Jakarta.

The tabular form has been filled on the basis of the Decree of the Minister of Trade, No.09/Kp/I/87 dated 15 January 1987.

The Decree of the Minister of Trade No.723/Kp/XII/83 dated 2 December 1982, as circulated as Document TEX.SB/965/Add.1 on 18 June 1984, is now superseded by the new regulation.

The new decree had been issued in the framework of "further simplification in import regulations" and a number of textile products have been de-regulated, while a number remain subject to trade regulations (see list).

All other textile products which are not included in the list can be freely imported into Indonesia.

Under the Decree of the Minister of Trade No.9/Kp/1/87 dated 15 January 1987, certain textile products remain subject to trade regulations.

These products may be imported only by:

- a. Approved Importers (IT), namely all importers that obtain general trade licences to import commodities from abroad into the territory of Indonesia, with a special assignment to import certain commodities purposely directed by the Government,
- b. Producer Importers (IP), namely all producers/manufacturers, that obtain limited trade licences to import commodities required solely for their production process, into the territory of Indonesia.

The products subject to the trade regulations are attached.
