Memorandum to the Textiles Surveillance Body

Subject: Your request for information about restrictions on textiles trade applied by Macau (Your ref. TS/140-1.1).

Macao does not apply any restrictions, being the market access completely free.

Macao applies "voluntary restraint" on its textile exports for seven countries in the terms of bilateral agreements signed under MFA's article 4.
