
Modification of the bilateral agreement between the EEC and Pakistan

Note by the Chairman

Attached is a notification received from the EEC of a further modification of its bilateral agreement with Pakistan. Limits were agreed on blouses (Category 7) when imported into France, Ireland and Spain.

The bilateral agreement and previous modification are contained in TEX.SB/1431, 1432 and 1433.

In connection with the European Economic Community's Agreement on trade in textile products with Pakistan negotiated under Article 4 of the Arrangement and initialled on 12 September 1986, I have to inform you of the following.

During the course of 1987 imports of women's and girls' blouses (Category 7) from Pakistan to Ireland, Spain and France exceeded 10,000 pieces, 97,000 pieces and 213,000 pieces respectively, being the levels at which the Community could ask for consultations with a view to establishing a regional limit under the provisions of Article 8 of the Agreement. The Community being of the view that there was real risk of market disruption in this case, the two sides consulted on 18 December 1987 in pursuance of Article 16 of the Agreement. As a result of these consultations and in conformity with the provisions of the Agreement, Pakistan agreed to limit its exports as follows:

These new limits contained in the Agreed Minute annexed to this letter are herewith communicated under Article 4, paragraph 4 of the Arrangement, as a modification to the Community's Agreement with Pakistan.

## AGREED MINUTE

- 1. Delegations of the Islamic Republic of Pakistan and the European Community met in Brussels on 18 December 1987 to continue consultations in accordance with Article 8 of the Agreement on trade in textiles between Pakistan and the European Community initialled on 12 September 1986, held previously on 25-27 November and 1 December 1987.
- 2. As a result of these consultations it was agreed that Pakistan will limit its exports of women's and girls' blouses (category 7) to the Community's regions of Ireland, Spain and France to the following levels:
