With reference to your letter TS/140-1.1 dated 5 April 1988, I wish to inform you that Singapore does not have any restrictions on imports of textiles and garments into Singapore. However, exports of selected textiles and garments from Singapore to the following countries are subject to quantitative restrictions under the respective bilateral textile agreements concluded under Article 4 of the Arrangement:
