Notification under Article 4

Modification of the bilateral agreement between the EEC and Korea

Note by the Chairman

Attached is a notification received from the EEC of a further modification of its agreement with Korea. A restraint was agreed for the period 1 January 1988 to 31 December 1991 on woven fabrics of artificial fibres (Category 36) when imported into Italy.

Dear Ambassador,

In connection with the European Economic Community's Agreement on trade in textile products with the Republic of Korea negotiated under Article 4 of the Arrangement and initialled on 7 August 1986, I have to inform you of the following.

During the course of 1987, imports of woven fabrics of artificial fibres (category 36) from the Republic of Korea to Italy exceeded 60 tonnes, being the level at which the Community could ask for consultations with a view to establishing a regional limit under the provisions of Article 8 of the Agreement. The Community being of the view that there was real risk of market disruption in this case, the two sides consulted on 16 March 1988 in pursuance of Article 17 of the Agreement. As a result of these consultations, and in conformity with the provisions of the Agreement, the Republic of Korea agreed to limit its exports as follows.

These new limits contained in the agreed minute annexed to this letter are herewith communicated under Article 4, paragraph 4 of the Arrangement, as a modification to the Community's Agreement with the Republic of Korea.

- 1. A delegation of the Republic of Korea and a delegation of the European Economic Community met in Brussels on 16 March 1988 for consultations under Article 8 of the bilateral Agreement on trade in textiles initialled on 7 August 1986.
- 2. As a result of these consultations the Republic of Korea agreed to limit its exports of products falling under <u>category 36</u> to the Community's region of Italy as follows:
