- (b) Amendments to the restraint limits of Category 10 set out in Annex II of the HK/EEC Textiles Agreement (1987-1991) with effect from 1 January 1988 due to the transfer of rubberised knitted gloves from Category 67 to Category 10 on the implementation of the Harmonized System.
- Amendments to Annex II of the HK/EEC Textiles Agreement (1987 - 1991)in respect of the restraint limits of Category 7 and Category 78 with effect from 1 January 1988 due to the migration of woven tops with shoulder straps and woven tops without opening from Category 78 to Category on implementation of the Harmonized System.
