ARRANGEMENT REGARDING INTERNATIONAL TRADE IN TEXTILES

Notification under Article 4

Modification of the Bilateral Agreement Between the EEC and Indonesia

Note by the Chairman

Attached is a notification received from the EEC of a further modification of its agreement with Indonesia. A restraint on T-shirts and knitted shirts (Category 5) when imported into the Community was agreed for the period 20 March 1990 to 31 December 1991.¹

Dear Ambassador,

In connection with the European Economic Community's Agreement on trade in textile products with Indonesia negotiated under Article 4 of the Arrangement and initialled on 28 June 1986, I have to inform you of the following.

During the course of 1989 imports of T-shirts and knitted shirts (Category 5) from Indonesia to the Community exceeded 2 199 000 pieces, being the level at which the Community could ask for consultations with a view to establishing a limit under the provisions of Article 8 of the Agreement. The Community being of the view that there was a real risk of market disruption in this case, the two sides consulted on 21-23 May 1990 in pursuance of Articles 8 and 16 of the Agreement. As a result of these consultations and in conformity with the provisions of the Agreement, Indonesia agreed to limit its exports to the Community as follows:

* This annual level for 1990 is to be applied from 20 March - 31 December 1990 (14 390 000 pieces).

These new limits contained in the Agreed Minute annexed to this letter are herewith communicated under Article 4, paragraph 4 of the Arrangement, as a modification to the Community's Agreement with Indonesia.

A G R E E D M I N U T E

1. Delegations of the Republic of Indonesia and the European Economic Community met in Brussels from 21 to 23 May 1990 for consultations in accordance with Article 8 of the Agreement on trade in textile products between Indonesia and the European Economic Community Initialed on 28 June 1986.
2. As a result of these consultations, it was agreed that Indonesia will limit its exports of cat. 5 products to the European Economic Community to the following levels:

3. The annual restriction level for 1990 is to be applied pro rata from 20 March 1990 as set out below:

5. It is likewise agreed that the provisions of the Agreement which concern exports of products subject to quantitative limits established in Annex II of the Agreement shall apply to the exports referred to above from 20 March 1990.
