Dear Mr. Ambassador,

Pursuant to Article 4:4 of the Arrangement regarding International Trade in Textiles as extended by the 1986 and 1991 Protocols, I am pleased to notify the Textiles Surveillance Body of certain amendments of the current bilateral textile Agreement between the Government of the Kingdom of Norway and the Government of the Republic of Indonesia.

The agreement has been extended by one year to 31 December 1992.

Furthermore, one new product category has been included in the Agreement. This new category, category 70, netting and nets, is subject to a certificate of origin surveillance system.

Certain uplifts have been agreed to for all categories. The limit on total flexibility has been abolished.

Please find enclosed a copy of the Agreed Minutes from the consultations between the two parties.



A G R E E D M I N U T E S


1. Delegations from the Government of the Kingdom of Norway and the Government of the Republic of Indonesia met in Jakarta on 11 - 13 December 1991 for consultations in accordance with Articles 15 and 17 of the Agreement between the Government of the Kingdom of Norway and the Government of the Republic of Indonesia relating to the exports from Indonesia of certain textile products for imports into Norway, signed at Jakarta on 13 May 1988.

2. As a result of these consultations it was agreed to initial the enclose amendment to the Textile Agreement as previously amended.

AMENDMENTS TO THE AGREEMENT BETWEEN THE GOVERNMENT OF THE KINGDOM OF NORWAY AND THE GOVERNMENT OF THE REPUBLIC OF INDONESIA RELATING TO THE EXPORTS FROM INDONESIA OF CERTAIN TEXTILE PRODUCTS FOR IMPORTS INTO NORWAY, SIGNED AT JAKARTA ON 13 MAY 1988.

I The Government of the Kingdom of Norway and the Government of the Republic of Indonesia have agreed to the following amendments to the Textile Agreement:

- (i) in Article 2, after "as extended by the Protocol of 31.7.1986" add "and as further extended by the Protocol of 31.7.1991"
- (ii) in Article 3, second line, delete "31 December 1991" and replace it with "31 December 1992".
- (iii) after Article 6, add the following text :

6 bis. The Government of Indonesia will, for the category in Annex A marked with an * issue a Certificate of Origin only.
- (iv) delete Article 7, paragraph (d) on total flexibility.
- (v) replace the existing Annex A on product coverage, with the attached Annex A.
- (vi) replace the existing Annex B on restraints, with the attached Annex B.

II These amendments will take effect on 1 January 1992.

PRODUCT CATEGORIES COVERED BY THE AGREEMENT

Category Number	Unit	Description
1.	Pieces	Outer garments of woven material, men's, boy's, women's, girl's: Jackets, tailored jackets, blazers, waistcoats, sports jackets (including parts of ski suits), anoraks and similar garments, parkas, one-piece suits, and the like. also as parts of suits, sets and costumes (boys and girls with height above 152 cm).
2.	Pieces	Outer garments of woven material, men's boy's, women's, girl's: trousers, slacks, jeans, breeches, and the like (including bib and brace overalls), other than swimwear and shorts, also as parts of suits and sets (boys and girls with height above 152 cm).
5.	Pieces	Men's boy's shirts of all kinds, of woven material (boys with height above 152 cm).
7.	Kgs	Bed linen (bed sheet, pillow case, quilt cover and the like).
70. *	Kgs	Knotted netting, made up fishing nets, other made up nets, and the like.
