Dear Mr. Ambassador,

Pursuant to Article 4:4 of the Arrangement regarding International Trade in Textiles as extended by the 1986 and 1991 Protocols, I am pleased to notify the Textiles Surveillance Body of certain amendments of the current bilateral textile Agreement between the Government of the Kingdom of Norway and the Government of the Czech and Slovak Federal Republic.

The agreement has been extended by 18 months to 31 December 1993.

The restraint for one category, category 5, has been abolished.

Certain uplifts have been agreed for the remaining categories. Annual growth rates have been increased from 1% to 3%. Swing has been increased from 2,5% to 3%. Carryover and carryforward, previously set at 8% and 5%, are now 10% and 5%. The limit on total flexibility has been abolished.

Please find enclosed a copy of the Agreed Minutes from the consultations between the two parties.

AGREED MINUTES

- 1. Delegations from Kingdom of Norway and the Czech and Slovak Federal Republic met in Prague on 16 18 June 1992 for consultations in accordance with Articles 19 and 15 of the Agreement relating to the exports from the Czech and Slovak Federal Republic of certain textile products for imports into Norway, signed at Oslo on 9 March 1987.
- 2. As a result of these consultations it was agreed to initial the enclosed amendments to the Textile Agreement as previously amended.

AMENDMENTS

AMENDMENTS TO THE AGREEMENT BETWEEN THE GOVERNMENT OF THE KINGDOM OF NORWAY AND THE GOVERNMENT OF THE CZECH AND SLOVAK FEDERAL REPUBLIC RELATING TO THE EXPORTS FROM THE CZECH AND SLOVAK FEDERAL REPUBLIC OF CERTAIN TEXTILE PRODUCTS FOR IMPORTS INTO NORWAY, SIGNED AT OSLO ON 9 MARCH 1987.

- I. The Government of the Kingdom of Norway and the Government of the Czech and Slovak Federal Republic have agreed to the following amendments to the Textile Agreement:
 - (i) Throughout the Agreement the term "Czechoslovak Socialist Republic" is replaced by the term "Czech and Slovak Federal Republic".
 - (ii) In Article 2, after "as extended by the Protocol of 31.7.1986" add "and as further extended by the Protocol of 31.7.1991".
 - (iii) After Article 6, add the following text:

Designated consultation levels:

- 6 bis. (a) The categories listed in Annex B marked with + are subject to the designated consultation levels specified therein.
- (b) If the Government of the Czech and Slovak Federal Republic wishes to export textile products to Norway in excess of the applicable designated consultation levels, the Government of the Czech and Slovak Federal Republic shall request the higher levels. The Government of Norway shall respond promptly and make every effort to resolve the issues within

14 working days of the receipt of the initial request. If the Government of Norway is unable to comply fully with the request due to problems of market disruption or real risk thereof, as described in Annex A of the Arrangement, in a category subject to such request the Government of Norway will so inform the Government of Czech and Slovak Federal Republic.

- (c) The Government of Norway will supply data in accordance with paragraphs I and II of Annex A of the Arrangement to substantiate the position it has taken. The two Governments unless agreed otherwise, shall consult as soon as possible within 30 days of the Norwegian denial of the request and shall make every effort to conclude such consultations within 30 days of its commencement. Until a mutually satisfactory change in the consultation level in question is established, shipments shall not exceed the existing consultation level.
- (iv) delete Article 7, paragraph (d) on total flexibility.
- (v) in Article 14, page 9, ninth line from the top, delete "total imports and".
- (vi) in Article 18, second line, delete "30 June 1992" and replace it with "31 December 1993".
- (vii) replace the existing Annex A on product coverage, with the attached Annex A.
- II. These amendments will take effect on 1 July 1992.
