With reference to Article 4 and paragraph 2 of Annex B of the Arrangement regarding International Trade in Textiles, done at Geneva on December 1973 as extended by the 1986 Protocol and subsequent Protocols, I have the honour to notify to the Textiles Surveillance Body the Agreed Minutes between the Government of Finland and the Government of Singapore extending the validity of the Memorandum of Understanding expiring on 31 December 1992 for the period 1 January to 31 December 1993.

The growth rate for 1993 is 5 per cent. A provision for a carryover flexibility of eleven (11) per cent from 1992 to 1993 is included.


## AGREED MINUTES


A Delegation of the Government of Finland and a Delegation of the Government of Singapore consulted in Brussels on 25 November 1992, on the desirability of extension of the Memorandum of Understanding applicable for the period of 11 January 1992 to 31 December 1992, should the Uruguay Round transition arrangements for integration of the textile sector into the GATT not come into force in Jan 1993.

Having regard to the Arrangement Regarding International Trade in Textiles, in particular Article 4 and Paragraph 2 of Annex B, agreement was reached as follows:

- 1 The validity of the Memorandum of Understanding is extended for the period 1 January 1993 to 31 December 1993, subject to the modifications set out below.
- 2 A carryover flexibility of eleven (11) per cent from 1992 to 1993 is applicable.
- 3 The growth rate for 1993 is 5 per cent.
