Note by the Chairman

Attached is a notification received from Finland of a memorandum of understanding with Romania, which will enter into effect on the entry into force of the Free Trade Agreement between the EFTA States and Romania and remain in effect until 31 December 1994. This memorandum replaces the previous memorandum of understanding.¹

With reference to Articles 7 and 8 of the Arrangement regarding International Trade in Textiles, done at Geneva on 20 December 1973 as extended by the 1986 Protocol and subsequent Protocols, I have the honour to notify to the Textiles Surveillance Body the Agreed Minutes between the Government of Finland and the Government of Romania replacing the Memorandum of Understanding relating to imports of certain textile products from Romania to Finland of 5 October 1990.

These Agreed Minutes, done at Geneva on 5 October 1993, will enter into force at the date of entry into force of the Free Trade Agreement between the EFTA States and Romania and remain valid till the 31 December 1994.

AGREED MINUTES

1. The Delegations of the Government of Finland and the Government of Romania consulted in Helsinki on July 19-20, 1993, on the compatibility of the Memorandum of Understanding relating to the export from Romania of certain textile products for import into Finland, signed on October 5, 1990, with the Free Trade Agreement between the EFTA States and Romania, signed on December 10, 1992. The Memorandum of Understanding is hereinafter referred to as the MOU, and the Free Trade Agreement as the FTA. The Delegations agreed on the following.
2. These Agreed Minutes replace the MOU as of the date of entry into force of the FTA in Finland and Romania. The Agreed Minutes are valid for a period ending on December 31, 1994.
3. Romania will forward to Finland quarterly statistics, on a cumulative basis, on exports of the textile products referred to in Annex I to these Agreed Minutes to Finland in accordance with the relevant provisions of the FTA.
4. Finland will forward to Romania quarterly statistics, on a cumulative basis, on imports of the textile products referred to in Annex I to these Agreed Minutes, imported from Romania to Finland in accordance with the relevant provisions of the FTA.
5. The Government of Finland and the Government of Romania agree to exhaust maximally the direct consultation procedure referred to in Paragraph 1 of Article 25 of the FTA, before initiating the procedure for the application of safeguard measures set out in that Article.
