Dear Mr. Ambassador,

Pursuant to Article 4:4 of the Arrangement regarding International Trade in Textiles as extended, I am pleased to notify the Textiles Surveillance Body of certain amendments of the current bilateral textile agreement between the Governments of the Kingdom of Norway and the Islamic Republic of Pakistan.

The Agreement has been extended by two years to 31 December 1995. The Agreement will be terminated automatically as of the implementation date of the Uruguay Round.

The Agreement has furthermore been changed in respect of the following elements:

- base levels have been increased by more than 6% for one category and by more than the applicable growth rate for two categories,
- annual growth rates have been increased from 3% to 5% for two categories and from 1% to 2% for one category,

sincerely,

swing has been improved, from 1 - 3% to 5%.

- 1. Delegations from the Government of the Kingdom of Norway and the Government of the Islamic Republic of Pakistan met in Islamabad on 2 4 November 1993 for consultations in accordance with Articles 15 and 17 of the Agreement between the Government of the Kingdom of Norway and the Government of the Islamic Republic of Pakistan relating to the exports from Pakistan of certain textile products for imports into Norway, signed at Islamabad on 5 July 1989.
- 2. As a result of these consultations it was agreed to initial the enclosed amendments to the Textile Agreement as previously amended.

Santum Head of the Pakistan Delegation AMENDMENTS TO THE AGREEMENT BETWEEN THE GOVERNMENT OF THE KINGDOM OF NORWAY AND THE GOVERNMENT OF THE ISLAMIC REPUBLIC OF PAKISTAN RELATING TO THE EXPORTS FROM PAKISTAN OF CERTAIN TEXTILE PRODUCTS FOR IMPORTS INTO NORWAY, SIGNED AT ISLAMABAD ON 5 JULY 1989.

- I The Government of the Kingdom of Norway and the Government of the Islamic Republic of Pakistan have agreed to the following amendments to the Textile Agreement as previously amended:
- (i) In article 2, after "as further extended by the Protocol of 31.7.1991", add "and the Protocol of 9.12.1992".
- (ii) Replace Article 3 by the following text:
 - "3. This Agreement shall apply for the period 1 January
 1988 31 December 1995. However, if the Agreement on trade
 in textiles and clothing products resulting from the Uruguay
 Round GATT trade negotiations is concluded and enters into
 force at an earlier date, this Agreement shall be
 automatically terminated as of the date agreed for the
 implementation of the results of the Uruguay Round GATT
 trade negotiations."
- (iii) Replace the existing Annex B on restraints, with the attached Annex B.
- II These amendments take effect as of 1 January 1994.
