

Austria	COM.TEX/SB/1860	An agreement covering the period 1 February 1993 to 31 December 1994, which was notified to the TSB under TEX.SB/2013.
Canada	COM.TEX/SB/1843	A modification and extension of the HK/Canada Textiles Agreement (1987-91), as extended once to 31.12.93, notified to the TSB under TEX/SB/3002 to cover the period of 1 January 1994 to 31 December 1995
EU	COM.TEX/SB/1840	Extension of the HK/EU Textiles Agreement (1 January 1986 - 31 December 1992) for a medium period of 3 years, subject to the entry into force of the UR Agreement on Textiles and Clothing. Agreement was notified to the TSB under TEX.SB/1986.
Finland	COM.TEX/SB/1885	An extension of the HK/Finland Textiles Agreement (1 January 1992 - 31 December 1993) for a maximum of two years up to 31 December 1995, subject to the entry into force of the UR Agreement on Textiles and Clothing. Agreement notified to the TSB under TEX.SB/2040.

USA	COM.TEX/SB/1682	A modification and an extension of the HK/US Textiles Agreement (1986-91), notified to the TSB under TEX.SB/1803 to cover the period of 1 January 1992 to 31 December 1995.
Norway	COM.TEX/SB/1761	An extension of the HK/Norway Textiles Agreement (1 July 1992 - 31 December 1993) for a maximum period of 2 years up to 31 December 1995, to be automatically terminated upon entry into force of the UR Agreement on Textiles and Clothing. Agreement notified to the TSB under TEX.SB/2064.
