SLOVENIA

The Textiles Surveillance Body received a notification from Slovenia in accordance with the provisions of Article 2:1 concerning the restrictions maintained by it on imports of textile products. Slovenia accepted the MFA as extended by the 1986 Protocol on 7 November 1994.

With reference to the request of the Textile Surveillance Body, dated November 10th, 1994, and according to Article 2, paragraph 1 of the Agreement Regarding International Trade in Textiles, the Government of the Republic of Slovenia hereby notifies the present status of restrictions that it maintains on products covered by the Agreement.

Upon declaring independence, the Republic of Slovenia, by its Constitutional Law, has taken over in its national legal system all international obligations of the former SFRY including all agreements to which that state had been a party. This only had an internal legal effect.

On February 21st, 1994, by an act of Parliament, the Republic of Slovenia incorporated into its legal system the Agreement Regarding International Trade in Textiles and the 1986 Protocol of Extension.

The current legislation governing the trade in textiles and clothing is the following:

- the Law on Foreign Trade, which in Article 8, paragraphs 2 and 4 delegates the authority to the Government to classify goods under import regimes by decree
- the Decree on the manner of classification of goods into export and import regimes (import quotas) (Official Gazette No. 41/93, 43/93, 68/94)
- the Decree on the manner, periods and conditions for the allotment of import quotas for goods (Official Gazette No. 15/1993)
- the Decree for the determination of import quotas for goods in the year 1994

(Official Gazette No. 72/93).

All existing quantitative restrictions currently applied by the Republic of Slovenia on textile and clothing products are unilateral. The Republic of Slovenia does not have bilateral agreements on imports of textiles and clothing, which have a restrictive effect, therefore, all restrictions on the importation of listed textile and clothing products apply to products originating from all countries. These products are listed in the enclosed lists.

The Republic of Slovenia concluded free trade agreements with the Former Yugoslav Republic of Macedonia, Hungary, the Czech Republic, and Slovak Republic. These agreements stipulate that no quantity restrictions shall be applied on imports and exports of countries, the parties to these agreements.

The Law on Foreign Trade contains the main principles applicable to regulating import quotas. The government decrees specify the products subject to import licensing and main principles and criteria for allocation of import quotas.

The Law gives power to the Government to implement its provisions and consequently to decide which products shall be subject to licensing in line with the international obligations of the Republic of Slovenia. The system of licensing can be abolished by the Government without a prior change of the Law.

Information on annual quotas is published in the Official Gazette and in other appropriate journals. The levels of quotas are global quota levels expressed in quantitative terms. The Republic of Slovenia does not use value based quota determinations. Current information on the status of utilization of quotas, during a current year is also published, in order to invite subsequent applications from potential applicants. Licenses are issued for a limited period of time (90 days), with the possibility of extension or renewal.

Import quotas are determined on an annual basis by the Government and then allocated through the appropriate associations of economic entities within the Chamber of Economy of Slovenia on the basis of a simultaneous examination of all applications of economic entities at a joint meeting of interested applicants, at the beginning of a calendar year. These are non-automatic import licensing procedures.

The authorized associations are:

- Association of Textiles and Clothing Producing Companies
- Association of Commercial Trading Companies
- Small Business Association.

The first Association deals with items under HS tariff lines from 51.11 to 55.26 (fibres, yarns and piecegoods), the second Association deals with semi-finished and finished textile products and clothing (61.01 to 63.02), and the third Association deals with all items according to the needs of small business.

The Associations each set aside 10% of the global quota for reserves, which are used for new suppliers or importers. The Producers' Association and Traders' Association each allow 5% of their global quotas for the Small Business Association.

Any company, whether or not it is associated in an association, may equally compete for a quota allotment and file an appropriate application, without preconditions. In the case of unused or unfulfilled quotas, companies may file additional applications for subsequent allotments.

Decisions concerning allotments may be contested at the Ministry of Economic Relations and Development in the first instance and appealed before an administrative tribunal in accordance with the general rules for administrative appeals. For a final judgment the matter may be referred to the Higher Court.

The Republic of Slovenia does not use any measures other than the quantitative restrictions which may restrict the trade in textiles and clothing for reasons of a dependence upon the availability of foreign exchange, or imports through state-trading enterprises or other enterprises which may enjoy exclusive or special rights.

The Republic of Slovenia applies special measures for the prevention of transshippment and circumvention. These are based on the rules of origin for textile and clothing products. These measures are comprised in several government level decisios, which are the following:

- level decisios, which are the following:
 the Decision on the rules of origin (Official Gazette of the SFRY No. 41/79 still valid)
- the Decision on the presentation of a certificate of origin upon the import of certain goods
 - (Official Gazette No. 18/93, 66/93)
- Decision on the standards regarding the imports of jute, wool and cotton (Official Gazette of the SFRY No. 36/78, 60/84, 65/84, 44/88 still valid).

The Customs Authority keeps records of imports and exports on a company by company level and by country of origin for the purposes of control. The Slovene Chamber of Economy is

authorized to issue certificates of origin (Form A) for imported goods which have been processed in the Republic of Slovenia and are being reexported. The value added must exceed 51%. The Customs Authority issues certificates EUR/1, EUR/2, certifying the origin of goods upon export from the Republic of Slovenia.

Statements or presentations made by companies through their representatives, which may be deceitfull or may constitute an attempt to deceive or defraud with regards the origin of goods, are punishable by law as a felony, with full responsibilities of the company as a juridical person as well as their representatives.

All rules and procedures with regard to the regulation of imports of textiles and clothing in the Republic of Slovenia are published in advance of their use, which applies to modifications as well, in the Official Gazette as well as the Economic Journal of the Slovene Chamber of Economy. In addition to that periodic public announcements are made for the convenience of-companies.

The Republic of Slovenia, after gaining independence in 1991, took over the import restrictions on textiles and clothing from the former SFRY and continued the system throughout 1992. In 1993 the Republic of Slovenia increased the level of the quotas by 20% and continued the restrictions at the same level in 1994. In this period of Republic Slovenia time, the of lost most preindependence export markets for textiles and clothing and was forced to assist a difficult process of industrial adjustment of its textile processing industry as well as secure new markets. On the other side, the Republic of Slovenia became exposed to a substantially competition in its market. The Government maintains import quotas only on those products in which an actual threat of market distortion exists. An actual threat is in the fact that these products are offered at prices which are substantually below those prevailing for similar goods of comparable quality in the Republic of Slovenia.

Nevertheless, the Republic of Slovenia did not increase the scope of or otherwise intensify the measures that it tookover from the former SFRY. The textiles and clothing sector in the Republic of Slovenia is a particularly sensitive sector and therefore the country will continue the process of restructuring this particular sector and maintain the previous levels of quantitative restrictions in the year 1995 with the necessary corrections or steps of liberalization.
