Dear Mr. Chairman:

Pursuant to paragraph 4 of Article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my government to inform the TSB of the amendment of the cotton, wool and man-made fiber bilateral textile agreement between the Government of the United States of America and the Government of the Republic of Korea. The original agreement was notified to the TSB and subsequently circulated to the TC as COM.TEX/SB/327.

The purpose of the amendment was to increase the consultation level for category 627 to 2,000,000 syds. equiv. for the first agreement year (from the applicable standard consultation level of 1,000,000 syds. equiv.) and to increase, for the second agreement year, the designated or applicable standard consultation levels for 18 categories of textile products.

Attached hereto is a copy of State Department Press Release No. 5 setting forth full, self-explanatory texts of the Note exchange giving effect to the amendment.

> UNITED STATES AND THE REPUBLIC OF KOREA AMEND TEXTILE AGREEMENT

The United States and the Republic of Korea exchanged notes December 28, 1977 to amend the existing bilateral textile agreement. The texts of the notes follow:

UNITED STATES NOTE

December 28, 1978

His Excellency Yong Shik Kim Ambassador of Korea

Excellency:

I have the honor to refer to the agreement of December 23, 1977, relating to trade in cotton, wool and man-made fiber textiles and textile products, with annexes, as amended, between the Government of the Republic of Korea and the Government of the United States (the "Agreement") and to consultations between representatives of the Government of the Republic of Korea and the Government of the United States of America held in Washington from November 16 to November 21, 1978, pursuant to paragraph 6 of the Agreement.

On the basis of these consultations, I have the honor to propose on behalf of the Government of the United States of America that the Agreement be amended as follows:

1) The consultation levels established in Annex C to the Agreement, as amended pursuant to paragraph 2 hereof, shall be applicable during the second Agreement Year.

2) Annex C is amended by changing the consultation levels for the following categories to the amounts set out below:

3) The consultation level for the first Agreement Year for Category 627 shall be 2,000,000 square yards equivalent.

If the foregoing conforms with the understanding of the Government of the Republic of Korea, this note and Your Excellency's note of confirmation on behalf of the Government of the Republic of Korea shall constitute an amendment to the Agreement.
