I have been informed by my authorities that there have been no changes made since we last reported to you.

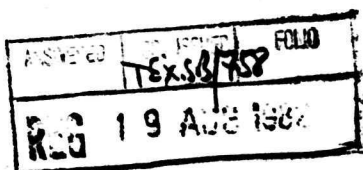
