our previous notification submitted on 30 July 1981.

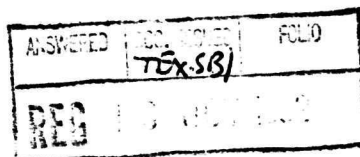
Therefore our information, presented in conformity
