With reference to your letter No. TS/140-1 dated 23rd July 1982 to our Trade Attaché, I am pleased to inform you that the import regulation of Indonesia on certain textiles products described below as reported by our representative to Textiles Surveillance Body (Mr. H.SAFIOEN) in 1981 has not been changed.

Description of products are as follows :

- (i). 55.09.40/42 - blacu : coarse cotton grey shirting;
- (ii). 55.09.90 - lurik : coarse cotton coloured .  
stripe cloth;
- (iii). 61.02.19/90 - cele : check pattern;
- (iv). 61.02.10/55.09.76 - batik and batik design prints;
- (v). And regulated import subject to licence for :  
55.05.10/60 - coarse and medium count cotton yarn  
between No. 12 to 42.

I hope this information would be of some use to you.
