Following my letter No. 564-G/83 of 30 July 1983, I have the honour to transmit to you the reply of the Ambassador of Brazil in Vienna (dated July 19, 1983, ref.No. 579) to the letter of director Waas of July 6, 1983. This reply contains the written agreement of Brazil to the Austrian proposals concerning a changement of the bilateral agreement between Austria and Brazil of October 1982.

Furthermore, it was agreed between Austria and Brazil that in the penultimate paragraph on page 1 of the introductory letter of 6 July 1983 it should be read "Para.(9)" instead of "Para.(8)".
