I am writing with regard to paragraphs 3 and 4 of the Agreement between the United States and the Republic of the Philippines Relating to Trade in Cotton, Wool and Man-Made Fiber Textiles and Textile Products, effected by exchange of notes November 24, 1982 ("The Agreement") and to discussions between representatives of our two governments concerning exports from the Republic of the Philippines to the United States of products classified in textile category 631.

On behalf of my government, I would like to propose that:

1. Annex A of the Agreement be amended to delete category 631 (man-made fiber gloves) and to add the following categories under the heading of manmade fiber:
