The imports of textile products effected in 1982. were subjected to import restrictions notified by Yugoslavia in 1981. and contained in document COM.TEX/SB/733/Add.27.
4. From June 1983. imports of a number of textile products were liberalized (total of 34 tariff lines). The liberalization covers import value of 3,542 million dinars in 1982.
