Note by the Chairman

Attached is a notification received from Sweden, concerning the further provisional extension of its bilateral agreements with the Philippines and Pakistan until 31 October 1983 and 31 March 1984 respectively.¹


Dear Mr Ambassador,

This is to inform you that an understanding has been reached between the Philippines and Sweden on a further prolongation of the agreement on trade in textiles for a period of four months ending 31 October 1983.

A similar arrangement has also been agreed upon with Pakistan for a period of nine months ending 31 March 1984.

These prolongations have been agreed upon between the parties in order to afford additional time for consultations on new agreements.
