Pursuant to the provisions of paragraph 4 of Article 4 of the Arrangement Regarding International Trade in Textiles, I am instructed by my government to inform the Textiles Surveillance Body of two extensions of the cotton, wool and man-made fiber textile agreement between the Government of the United States of America and the Government of Yugoslavia, the latter extending the agreement through December 31, 1985.

Belgrade December 27, 1983

The Embassy of the United States of America presents its compliments to the Federal Secretariat for Foreign Affairs of the Socialist Federal Republic of Yugoslavia and has the honor to refer to the Agreement between the United States of America and the Socialist Federal Republic of Yugoslavia concerning trade in men's and boys' wool and man-made fiber suits, effected by exchange of Notes dated October 26 and 27, 1978 ("the Agreement") as extended and amended by the exchange of Notes dated July 15 and September 12, 1980.

The United States Government proposes that the Agreement be extended for three months, and therefore be amended as follows:

- -- The term of the Agreement shall be extended through March 31, 1984, so that the last Agreement year shall be a fifteen-month period from January 1, 1983 through March 31, 1984. The group limit for the last Agreement period shall be 21,499 dozen, and the limit on category 443 shall be 10,136 dozen.
- -- The flexibility provisions specified in the Agreement shall pertain to the Agreement as extended and amended.

If the foregoing proposal is acceptable to the Covernment of the Socialist Federal Republic of Yugoslavia, this Note and the Secretariat's Note of confirmation on behalf of the Government of the Socialist Republic of Yugoslavia shall constitute an amendment to the Agreement.

Belgrade February 21, 1984

The Embassy of the United States of America presents its compliments to the Federal Secretariat for Foreign Affairs of the Socialist Federal Republic of Yugoslavia and has the honor to refer to the Agreement between the United States of America and the Socialist Federal Republic of Yugoslavia concerning trade in men's and boys' wool and man-made fiber suits, effected by the exchange of notes dated October 26 and 27, 1978, as extended by the exchanges of notes dated July 15 and September 12, 1980 and December 27 and 30, 1983, ("the Agreement").

Pursuant to discussions held between representatives of our governments in Belgrade on January 26, 1984, the Embassy would like to propose that the Agreement be amended and extended as follows:

1) The three-month extension of the Agreement effected by the exchange of notes dated December 27 and 30, 1983 shall be superseded by a two-year extension, so that paragraph one of the Agreement shall be changed to read:

"For each calendar year (agreement year) during the period from January 1, 1978 through December 31, 1985, exports of men's and boys' wool and man-made fiber suits from Yugoslavia to the United States are subject to the limits set out in this Agreement."

- 2) Paragraph two of the Agreement shall be amended by adding the following sentence: "The group limit shall be 19,000 dozen for the 1984 agreement year and 20,140 for the 1985 agreement year."
- 3) Paragraph three of the Agreement shall be amended by adding the following sentence: "The limit for men's and boys' wool suits shall be 8,200 dozen for the 1984 agreement year and 8,282 dozen for the 1985 agreement year."
- 4) The first sentence in paragraph five of the Agreement shall be amended to specify that "carryforward shall not be applied to calendar year 1985."

If the foregoing conforms with the understanding of the Secretariat, this Note and the Secretariat's Note of confirmation on behalf of the Government of the Socialist Federal Republic of Yugoslavia shall constitute an amendment to the Agreement.

Pursuant to discussions held between representatives of our governments in Belgrade on January 26, 1984, the Embassy would like to propose that the Agreement be amended and extended as follows:

EMBASSY OF THE UNITED STATES OF AMERICA

BEOGRAD

- 1) The three-month extension of the Agreement effected by the exchange of notes dated December 27 and 30, 1983 shall be superseded by a two-year extension, so that paragraph one of the Agreement shall be changed to read: "For each calendar year (agreement year) during the period from January 1, 1978 through December 31, 1985, exports of men's and boys wool and man-made fiber suits from Yugoslavia to the United States are subject to the limits set out in this Agreement".
- 2) Paragraph two of the Agreement shall be amended by adding the following sentence: "The group limit shall be 19,000 dozen for the 1984 agreement year and 20, 140 for the 1985 agreement year".
- 3) Paragraph three of the Agreement shall be amended by adding the following sentence: "The limit for men's and boys' wool suits shall be 8,200 dozen for the 1984 agreement year and 8,282 dozen for the 1985 agreement year".
- 4) The first sentence in paragraph five of the Agreement shall be amended to specify that "carryforward shall not be applied to calendar year 1985".
- If the foregoing conforms with the understanding of the Secretariat, this Note and the Secretariat's Note of confirmation on behalf of the Government of the Socialist Federal Republic of Yugoslavia shall constitute an amendment to the Agreement.

The Embassy of the United States of America avails itself of the opportunity to renew to the Federal Secretariat for Foreign Affairs the assurances of its highest consideration".
