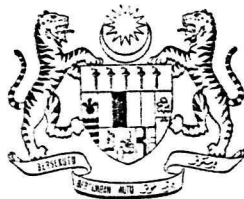


Updating of information pertaining to

With reference to your letter reference no. TS/140/1  
dated 8 February, 1984, I have the honour to submit the  
information as appended regarding the total ban on  
the importation of batik sarong (CCCN.No. 61.02.283,  
61.02.383, 61.02.483 and 61.02.983) into Malaysia  
which was effected on 18 March, 1984. The restriction  
was to cover a period of 2 years. This measure, however,  
is currently under review.

2. Apart from this measure, Malaysia does not maintain  
any other restrictions in the import of textiles and clothing.
