DRAFT AGENDA FOR THE ELEVENTH MEETING (1975)¹ OF THE TEXTILES SURVEILLANCE BODY

As agreed there will be a meeting of the Textiles Surveillance Body in the new ILO Building, Room X, R-2, on Monday, Tuesday and Wednesday, 15, 16 and 17 September. The meeting will start at 10.0 a.m. on Monday.

The following are the main subjects for discussion:
