5. Title: Establishment of the Labelling Standards for Class II Specified Chemical Substances Mentioned in the Item 4 Above, which are Designated by the Law Concerning Examination and Regulation of Manufacture, etc., of Chemical Substances (available in Japanese, 1 page)

- 6. Description of content: The following items shall be indicated collectively:
 - (a) the common name of products;
 - (b) the quantity of content;
 - (c) the name and address of the manufacturer (or importer for imported products);
 - (d) other items such as note and instructions for preventing environmental pollution.

- 8. Relevant documents: The Law Concerning Examination and Regulation of Manufacture, etc. of Chemical Substances.
