4. Organizational Structure and Management PSA is the Philippines national standards body responsible for standardization activities in the country. It is a government agency under the administrative supervision of the Ministry of Trade and Industry. The management of the office is done by a Director and an Assistant Director. To attain its principal objective which is to insure quality assurance of products, the PSA organized four divisions: the Product Standards <u>Development Division</u> - responsible for the preparation, promulgation and publication of product standards, and coordination with other standardizing organizations regarding programs on product standardization; the Product Inspection Division - responsible for implementation of national standards and evaluation of products for compliance; the Quality Assurance Division responsible for operation and evaluation of applications for a Philippine Standard Certification Mark or "PS" Mark and Commodity Clearance, accreditation of testing laboratories, and render quality control and metrication services; and the Technical Assistance Division - responsible for collection, retrieval, storage, dissemination and updating of information on standardization, standards promotion, and operation of the GATT Standards Code focal inquiry point. Attached is the present organizational chart of PSA.
