ORGANIZATION

IRA was created as a governmental agency under the jurisdiction of the Roll by a presidential decree No. 6464 on January 1973. IRA has nine export inspection institutes, Korean Standard Institute and Association under its control and supervision, as well as the National Industrial Research Institute and nine provincial testing branches as a subordinate unit.

Its main offices and functions are as follows:

Bureau of Quality Control

- Plan and implement policies on quality and safety control.
- Implement and enforce the Industrial Products Quality Control Law and the Electric Appliances Safety Control Law.
- Protect consumer rights.

Technical Guidance Officer

- Work out implement technical training guidance proprams.
- Provide assistance to the research and development activities.
- Control the national standard system for weights and measurements.
- Implement the Measurement Law.
- Provide technical services.

Bureau of Standards

- Establish and propagate the Korean industrial standards
- Operate the Korean Standard marking system.
- Cooperate with the International Standardization Organization (ISO, IEC etc.)
- Implement the Industrial Standardization Law.

Bureau of Inspection

- Plan and implement policies on the exports inspection system of industrial goods.
- Implement the Export Inspection Law.
