ABBREVIATIONS USED:

PROPOSAL: Initial proposal of tariff concessions

PAPR: Information on paper

DISK: information on PC diskette

TAPE: Information on computer tape

IDB : information in IDB format

EXP : Information to be submitted

PROGR: data being coded or converted into the Tariff Study format

PRELOAD: data being verified (values, duties, bindings etc.)

LOADED: file loaded for cross-checking between tariff and imports

READY: file available on computer tape in Tariff Study format
