CONVERSION PHASE CONTROL MESSAGES

Note by the Secretariat

Before a national submission is loaded in the IDB, the information is analysed, checked and converted, as described in the "Conversion phase" in document IDB/W/6. At each processing step, the conversion programs produce reports where control messages are printed.

The messages are stored in an IDB "system file" where they are grouped according to the file to which they refer. Each message is identified by a three-digit number and a one-letter code identifying the type of message: "E" for "error" messages, "I" for "information" messages and "W" for "warning" messages. The message text is abbreviated and recorded using seventy characters.

This paper contains a list of all "warning" and "error" messages printed in the reports produced by the conversion phase programs. A "warning" message is issued when the record in which the discrepancy is detected is kept in the output file created by the program. An "error" message is issued when the record in which the discrepancy is detected is <u>not</u> written in the output file created by the program.

The list of messages printed in the conversion control reports is reproduced in this paper to summarize the controls made during the conversion of IDB submissions.
