## Situation and Trends in Poland's Bovine Sector

(Information furnished by Poland)

The Polish delegation presents information on the present situation in the meat market and estimates for 1979, in regard to production and trade.

In 1978, the livestock population increased in comparison with the low level recorded in 1976. The relevant figures are as follows:

Exports are stable and no increase is expected in 1979.

In the bovine sector, which is of particular interest to us, we see no possibility of increasing our cattle and meat sales, because of weak demand in Europe which is likely to continue next year. Indeed, there has been an appreciable deterioration in the market and in demand for preserves, whether of beef or pork.

Our country intends to further intensify livestock production, but it must be underlined that this is a difficult and costly task in view of the very difficult conditions that agriculture is encountering after a fifth consecutive year of poor harvests.

#### Assessment of the world meat market

It seems to us that the brief assessment made of the international market in April was correct, particularly as regards barriers to trade which are still maintained without any spectacular change. The only positive signs, though not in the nature of trade liberalization, are the recent increases in quotas for the United States and Japan.

Nevertheless, we are awaiting with impatience the results of the Tokyo Round negotiations and the conclusion of a meat arrangement which might help to achieve free and orderly trade in the years to come.
