## REVISION OF INFORMATION ON PUBLIC NOTICE

### Note by the Secretariat

As agreed at the Committee meeting on 29 October 1991, the secretariat is preparing a revision of document LIC/4/Rev.3 concerning information on public notice as provided for in Article 3(d) of the Agreement on Import Licensing Procedures.

The information available in documents LIC/4/Rev.3 of 10 August 1983 and Rev.3/Add.1 of 1 October 1991 is annexed to this note. Parties are invited to inform the secretariat (Mrs. N. Perera, tel: 739 50 92) by 30 March 1992 of any changes they wish to make. The updated information will be issued as document LIC/4/Rev.4 shortly thereafter.

Article 3(d) of the Agreement on Import Licensing Procedures provides that "in the case of quotas allocated among supplying countries, the Party applying the restrictions shall promptly inform all other Parties having an interest in supplying the product concerned of the shares in the quota currently allocated, by quantity or value, to the various supplying countries and shall give public notice thereof".

At the meeting of the Committee held in April 1980, there was general agreement that delegations should indicate the way in which public notice is given (LIC/M/2, paragraphs 12 to 14).
